1. Except for Q&Q fares by INDIA from 10/10/2020 till 31/03/2021 for August 2020 travel, for cancellation charges on the basis of the basic fare plus fare change (if allowed) for all domestic booked fare change is always charged with Basic Fare.

Note:

1. Advance Changes are applicable per person. In case of 'non-refundable', Basic Fare will be refunded.
2. Rules of the Reserve Application Change and Difference of fare are applicable.
3. Governmental Fees: MSO rules will apply for change/cancellation of fare/advance.
4. In case of flight disruption.
5. Advance change/cancellation made by the airline. Not Refund.
6. Passengers is taken back to the point of origin by the first available carrier. Full amount to be refunded.
7. Other arrangements for the cancelled tickets are made in the passenger's behalf of Basic fare in the destination/city.
8. The percentage is not taken for the ticketed destination as per paragraph 2 unless basic arrangement. Full amount to be refunded in respective MSO along with cancelled non-refundable, if any.
9. No Per-destination Cancellation Fees applicable on refund ticket.
10. Taxes Refundable on request for change/cancellation.
