**Notes:**

1. Advance changes are applicable per person. In case of "non-refundable", Basic Fare will be refunded.
2. Rules of the Member Application Change and Difference of fare are applicable.
3. Governmental Fees: MSJ rules will apply for change/cancellation of LULU/GOLDFLAG.
4. In case of flight disruption.
5. Advance change/cancellation made by the Member: No Refund.
6. Passengers' taxes back to the point of origin by the first available carrier. Full amount to be refunded.
7. Other arrangements for the cancelled itinerary made by the passenger. Refund of Basic Fare to the destination.
8. The percentage is not taken for the ticketed destination at passenger's request based on management. Full refund to order in respective MSJ along with cancelled non-refundable, if any.
